NOTICE GIVEN UNDER SECTION 708A(5) OF THE CORPORATIONS ACT

This notice is given by Aspire Mining Limited (**Company**) under section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**) in relation to an issue of 1,595,900,000 fully paid ordinary shares by the Company on 3 December 2019 without disclosure to investors under Part 6D.2 of the Corporations Act.
